- **1.** Apologies for absence none as all Cllrs were present.
- **2.** Acceptance of minutes The minutes of the ordinary council meeting held on the 03rd June 2025 were unanimously agreed and signed by the chairman.
- 3. Declarations of interest for items on this agenda none.
- 4. To consider any applications for dispensations under section 33 of the localism act 2011 None received.
- **5. Public participation** none.
- **6.** Chairman's comments Cllr Martin had nothing to report.
- **7.** Councillors' questions and comments 24-hour notice in accordance with Standing Orders advisable Clerk to contact CC / Coastline for an update on the land behind Merther close.
 - It was noted the CC code of conduct training video is sufficient for Cllrs. Cllr Logan has completed this.
- 8. Cornwall councillor's comments Cllr Jenkin apologised for not making last months meeting due to attending the Celtic festival. The highways road build out at Nancegollan may have to be altered to gateways due to the extra costs required for lights around the build out and the highways budget not allowing for this. The CNP meeting is coming up in a few weeks. Although Cllr Jenkin no longer sits on the health and social care board, she attended a meeting on the 02.07.25 which discussed the possibility of a Cornwall Devon merged health board by 2027 for management and governance purposes. The ambulance service is no longer covering the cost for first responders, so alternative options are being investigated. It is particularly important in rural areas like the Lizard.
- 9. Planning: PA25/04153 Prospidnick Holding Prospidnick Hill Prospidnick Sithney Ground floor extension to existing house. It was considered that the proposal was not over ambition and would improve the amenity within the dwelling. It was RESOLVED that Sithney Parish Council supports the application.

 PA35/04533 Montarey Haylo Boad Nancorollan Holdton Form Banningtion to add a third 11ky everhead.
 - PA25/04523 Monterey Hayle Road Nancegollan Helston Form B application to add a third 11kv overhead wire to an existing line. As there is little information provided and that the application is for an additional overhead wire, it was RESOLVED that Sithney Parish Council support the application as long as it meets the requirements of the planning department.
 - PA25/04482 Trelyn Caravan Tuckingmill Lowertown Helston Cornwall TR13 0DB Non Material Amendment in relation to Decision Notice PA22/06619 dated 14.11.2022 in respect of remediation scheme. It was noted that the Public Protection Contaminated Land Consultation considered the remediation proposals appeared to be sufficient. It was RESOLVED that Sithney Parish Council support the application as long as the two suggested conditions are implemented.
